



## 2. Direct Sale Bonus (7%)

# SunEdge allocates 7% of the Company's monthly PV as Direct Sale Bonus (DSB).

This is computed by a "Point Sharing System" based on the Direct Sale Bonus points earned by the qualifiers.

DSB Point value varies each business month and is computed monthly as per the formula shown below:

### 4. Silver Director Bonus (3%)



# SunEdge allocates 3% of the Company's monthly PV as Silver Director Bonus (SDB). This is computed by a "Point Sharing System" based on the Silver Director Bonus points earned by the qualifiers. SDB Point value varies each business month and is computed monthly as per the formula shown below:

#### 7. Leadership Development Bonus (27%)

#### 8. Travel Bonus (3%)

- 2. For Travel Bonus you have required 2 BBB Achievers In 2 leg (1 Each Leg ) 53,000 in each Pearl director above any 2 leg in every business month
- 3. For Travel Bonus, you must achieve Business Building Bonus
- 4. This is also base upon the BBB qualifications and is paid out according to same

#### 9. Car Bonus (4%)



SunEdge allocates 4% of the Company's monthly PV as Car Bonus (CB).

This is computed by a "Point Sharing System" based on the CB points earned by the qualifiers. CB Point value varies each business month and is computed monthly as per the formula shown below:

- 3. For Car Bonus, you must achieve Leadership Development Bonus
- 4. This is also base upon the BBB qualifications and is paid out according to same

#### 10. House Bonus (4%)

SunEdge allocates 4% of the Company's monthly PV as House Bonus (HB). This is computed by a "Point Sharing System" based on the HB points earned by the qualifiers. HB Point value varies each business month and is computed monthly as per the formula shown below:

House Bonus Point Value = 4% of Company's Monthly PV / Total HB Points Collected

- 1. Qualify to House Bonus have required Platinum Director & 4 qualified Active Silver Directors and above group directly or indirectly under him/her with 1,25,000 PV required in that group )
- 2. For House bonus you have required 1,25,000 PV in each leg in every business month
- 3. This is also base upon the BBB qualifications and is paid out according to same

### 11. Royalty Bonus (2%)

SunEdge allocates 2% of the Company's monthly PV as Royalty Bonus (RB).

This is computed by a "Point Sharing System" based on the RB points earned by the qualifiers. RB Point value varies each business month and is computed monthly as per the formula shown below:
